You are quoted as requesting concrete proposals relative to the Wheat Quota.

I made "concrete proposal" and requested to both the Presier Sir David Brand and the Governor Sir Douglas Kendrew some time ago as a result of the Wheat Quota received by us, also in view of the proposed Legislation on Harketing Fat Lambs.

It has been clearly demonstrated to us the extent of disregard of the individual in the case of the Wheat Quota, and in the ensuring Fat Lamb Authority where in it is proposed that marketing shall be under License only and otherwise illegal. In which we with a Stud "Polwarth" flock were excluded from voting on strongly intermate that we would not receive a license. Although the Stud was purchased this year for the cross breeding purposes of producing Fat Lambs.

Some of my sons attended a district meeting and presented our case of disantimfaction to representatives dealing with problems relative to the Theat Quota.

* They are doing what they can to improve our position as would be correctly expected.

However on the matter being reported to me and giving it consideration. The assessment can result in only one conclusion, that the position has reduced us and my sons to the statute of beggars. Begging for higher Theat Quota allocations.

If thru sheer necessity other farmers must beg now as a result of your legislation.

I being the signatory for our families application for the Wheat Quota order that any investigating authority disregard my sone appeal.

I will not have my family reduced to a state of begging.

I will therefore only attend any meeting whose purpose is set to duely effect my request as given to the Covernor.
